- A follow-up meeting with internal members will be held on 14.09.2018 at 10.45 a.m. for preparation of AQAR 17-18.
- Dr.Milan Paul suggested that regular up-dating and up-gradation of College Website are required. The committee decided that it will be done by Dr. Radharaman Bar. For this purpose all data to be submitted to IQAC Coordinator.
- The newly introduced CBCS system needs a lot of input data, specially in terms of Students' Attendance and Internal Assessment. The Coordinator pointed out that Students' Attendance Register has not been provided by the office to the respective departments, for which teachers are facing lots difficulty to maintain records. The Committee asked Sri Swapan Bhaduri, Head Clerk to prepare Students'List on the basis of already registered students at the earliest and provide the same to the departments.
- A seminar on inter-disciplinary theme, preferably related to health issue, may be arranged during the first week of October. Alumni member Sri Biswajit Das proposed that a seminar on Orthopaedic Problems might be organised. The committee asked him to proceed in this regard.
- Since no fund has been received from the UGC after the newly constituted committee took charge, any expenses for conducting IQAC programme will be met up from College Fund.
- Promotion related works of five teachers are under process. Dr. Pal informed that in case the date of promotion falls during a period that includes both the new and the old regulations, an incumbent must fill up the PBAS forms for both the regulations.
- It was reported with appreciation that NSS wing and Students' Union of the college had already collected donation for Kerala Flood Relief. Dr. M. Paul suggested that some contribution may also be arranged for the same from college fund.
- Dr. Sreejata Biswas reported that she was intimated by the Teacher-in-Charge, who is also the Chairperson of IQAC, by a letter on 20.04.2018 that she had been selected by the Governing Body to act as IQAC Coordinator. On 11.08.2018 the charge was handed over to her from the previous Coordinator. She took the files, one laptop, one printer, one digital camera and photocopy of Audit Report. The files contain some loose minutes, but no Minutes Book was there within those files. The Utilization Certificate of the UGC Fund received during the tenure of the previous IQAC Coordinator was also not handed over to the new committee.
- It was also stated by the Coordinator that an almirah is urgently required for keeping the files and other assets of IQAC received by her. She had already requested the Teacher-in-Charge through a letter hoping that the same will be arranged soon. To place the said new almirah the committee requested Sri Jahar Lal Das to arrange a space preferably in the 3<sup>rd</sup> floor.

### **Business Arising**

- The Chairperson, Professor Shipra Halder welcomed new member Prof. Moumita Sarkar Samanta.
- Dr. Papiya Saha was selected as the Recording Secretary to record the proceedings of the meeting..
- A letter from the UGC (No. F. IQAC-W-087/13-14 (ERO) dated 7.12.2018) had been received for Resubmission of AQAR for the session 2014-15 and 2015-16 in their specified format and not as per NAAC format. The coordinator, IQAC will do the necessary work and send it to UGC after approval in the next meeting of IQAC.
- Entry of data for Students' Attendance and Internal Assessment under CBCS system necessitates having a dedicated phone and SIM. Wifi should be available in the Seminar Room so that data entry be possible from there without hampering the official work at the office of the Teacher-in-Charge. IQAC requested the Teacher-in-Charge to do the needful.
- Reconstitution of Cells to be done as early as possible and to be approved in G.B.
- College website redesigning is already in progress. The Coordinator requested college authority to reintroduce the Teaching-aid software for uploading lectures, notes and other teaching materials for the benefit of students.

- Considering the need for available teaching days it was decided to conduct Part III Selection Test during January 16-22, 2019, in respective departments without hampering other classes. No classes will be suspended during the exam.
- Considering the huge workload to conduct classes and field work in AECC2 (Environmental studies) in Semester 2 of B.A./ B.Sc. and B.Com Dr. P. Saha proposed that a new Guest Teacher may be appointed. Sri J.L. Das proposed that instead of appointing a new teacher for AECC2 the workload may be distributed among existing teachers of the departments of Botany, Zoology, Chemistry and Geography as per the C.U. rules. IQAC requested the coordinator to do accordingly following the proposal of Sri Das.
